



Draft Minutes  
**139th Annual General Meeting of the RSC**  
Held Virtually Via Zoom  
November 28, 2020, 15h00 – 16h00

## 1. Opening

As President, J. McNeil called the meeting to order at 15h45 and welcomed members. He invited S. Embleton to give a land acknowledgement.

J. McNeil noted that this has been a challenging year for all RSC members as well as for our families, friends, and colleagues around the world. Due to our continued focus on governance and management, the Board was well-positioned to respond to the complexities of the COVID-19 pandemic. For example, as noted in the annual report, the RSC either postponed or took all activities online as of March 13, and the Walter House Team worked remotely beginning on March 16.

This has also, however, been a year in which the mission of the RSC has been manifest in an organizational response to the COVID-19 pandemic. From the Board of Directors and Council, through the Walter House Team, the RSC Task Force on COVID-19, and the over 300 individuals (so far) engaged to date, the RSC has demonstrated the ways in which it continues a 138 year-long tradition of being purpose-driven.

This year's achievements, both nationally and internationally, have been grounded in objectives outlined in 2018-2022 strategic plan. At the national level J. McNeil highlighted the ongoing work of the Membership Committee and the RSC Task Force on COVID 19, chaired respectively by Marie D'Iorio and Tom Marrie. On the international scene the RSC, and under the leadership of RSC International Secretary Paul Young, the RSC has continued to emphasize engagement with the G7 and G20 Science academies, as well as with umbrella organisations such as IAP and IANAS. The annual report, on the RSC website under Resources, contains a full report on all activities.

The Board met on several occasions to oversee business continuity planning in light of COVID-19, and also met exceptionally to finalize two statements that are available on the RSC website. The first statement, published on June 9, addressed systemic racism, while the second, published on June 15, affirmed the RSC's commitment to inclusive excellence—recognizing that there is no excellence without meaningful inclusion.



The Board approved a six-month budget that runs from July 1 through the end of the calendar year, and will meet in December to consider a budget for the period of January 1 to June 30, 2021, once the results of fall activities and their financial impact have been fully assessed.

During the course of the year, the Governance and Ethics committee advanced a series of recommendations to institutionalize the responsibility for nominating members of the Board, members of Board committees, and overseeing the processes leading to the election of Academy Presidents and the President of the RSC College. The Board adopted these recommendations in late summer. J. McNeil noted that the Governance and Ethics Committee has begun planning for the upcoming presidential elections as well as for the position of RSC Secretary, and encouraged members to begin considering possible candidates.

Several years ago, a task force chaired by Ken Davey updated the RSC by-laws. A new series of updates, to enhance clarity and to remain in keeping with best practices, is now timely. However, due to the exceptional nature of this virtual annual meeting, the Board decided to defer proposed by-law changes until November 2021. In the coming year, the Board and management will continue to work with our legal counsel, auditing firm and Board Committees with a view to proposing a series of by-law amendments in November 2021. J. McNeil also invited members to send any suggestions re by-law changes to the Walter House Team.

J. McNeil noted that, once again this year, the agenda for the business meeting was reviewed by Deloitte to ensure consistency with best practices.

#### 4. Election of the Board of Directors

S. Embleton reviewed the context and process toward presenting a slate of Board Directors for the coming year. Of the 11 members of the Board, nine are continuing for the year ahead, and there are two new proposed members.

The first is Dr. Karly Kehoe, who was elected by the members of the RSC College as their next President. Dr. Kehoe therefore begins her term as a member of the RSC Board for a period co-terminous with her presidency of the College.

In October, due to health reasons, Jean-Marie Toulouse stepped down as Chair of the Finance Committee and member of the Board. At the request of the President, RSC Past-President Chad Gaffield agreed to serve as chair of the Finance Committee for its meeting of October 19<sup>th</sup>.

In keeping with Board policy, the Governance and Ethics Committee oversaw the process of identifying the successor to J.-M. Toulouse. Nominations for Chair of the Finance Committee were sought from the Board and from Council, with an emphasis on a current understanding of the RSC and a willingness to engage in this leadership role.

At the meeting of the Board on November 2, the Board ratified the recommended list of Board members for the coming year to be presented to the membership, including Vijaya Raghavan, immediate past-President of the Academy of Science, as Chair of the Finance Committee.

The Board therefore recommends ratification of this list of Board members to the membership for the coming year.

S. Embleton noted that, in keeping with best practices, since Deloitte has been the auditing firm for a number of years, there will be a request for proposals for the RSC auditors beginning in the year 2022. For the coming year, the Board recommends that Deloitte be confirmed as the auditors.
