**JOLENE ASHINI** | University of Victoria's Faculty of Law

Jolene Ashini is among the first cohort of graduates from the University of Victoria's JD/JID law program. She is a member of the Sheshatshiu Innu First Nation, located in Labrador, she grew up on reserve and on the land, within the Innu territory of Nitassinan.



**RAYENE BOUZITOUN** | Université d'Ottawa - Faculty of Law - Civil Law

Rayene Bouzitoun is currently completing a double major Bachelor's degree in Law and International Development at the University of Ottawa, where she is studying as a 2018 Loran Scholar. At the age of 18, Rayene was an inaugural member of the Prime Minister's Youth Council. Most recently, she worked with youth in northern Ethiopia to improve the health and rights of women and children through the Born on Time Program. Rayene has been involved in several community projects in the Saint-Michel borough, including the Forum Jeunesse de Saint-Michel, where she served as President for two years.

Rayene is even involved in Algeria, her native country. This year, she co-directed a fundraising project to provide the Skikda hospital with the necessary tools to respond to COVID-19.



**DAKOTA BUNDY** | Queen's University's Faculty of Law
